RE: Request that Studies be Required Immediately to Assess Environmental Effects of Decommissioning of Project 606 Kilarc- Cow Creek Proposed by PG&E

Dear Secretary Salas:


I attended the meeting convened by PG&E on September 12, 2007, at which time they presented their preliminary proposed decommission plan for a 30-day public comment period. At that meeting, I reiterated my request, made at the Scoping Meeting convened by PG&E on May 16, 2007, that PG&E conduct and disclose the results of environmental studies to identify the effects on migratory birds and other wildlife of the proposed draining and filling of Kilarc reservoir.

PG&E's project manager, Steve Nevares, replied that PG&E did not consider such study necessary, and would not conduct any further studies prior to submission of their license surrender application to the FERC in March 2009. PG&E informed the audience that the FERC would be the "judge and jury" in determining the environmental effects and preferred license surrender alternative, and would be relying on environmental studies prepared by PG&E to make such determination.

We, community stakeholders in this process, are angry that PG&E chooses to ignore public requests and delay for 18 months or more, undertaking studies that clearly are necessary to evaluate the effects of their proposed plan versus viable alternatives.

Please, order PG&E to immediately undertake appropriate environmental studies to identify the effects on migratory birds and other wildlife of the proposed draining and filling of Kilarc reservoir.


