Dear Ms. Bose:

Tetrick Ranch, on behalf of itself, the Abbott Ditch Users, and the County of Shasta, California, request a meeting with the Commission Staff in connection with the above-captioned hydroelectric proceeding. It is our understanding that the meeting will be noticed to the public by the Commission Staff, and accordingly, we request that the meeting be scheduled within an expedited notice time period of fifteen days, so that it may be held during the first full week in July, sometime between July 7 and July 10, 2009, but preferably on Wednesday, July 8, 2009, if possible.

We believe that the meeting could assist the Staff to become familiar with the local concerns and issues raised by the proposed Surrender of License Application filed by Pacific Gas and Electric Company ("PG&E"), the current Licensee for Project No. 606, as well as actions now being contemplated to best serve the communities most directly affected by Project No. 606 and PG&E's surrender proposal, and otherwise generally aid the proceeding.
