**NOTICE OF INTERVENTION
UNITED STATES DEPARTMENT OF THE INTERIOR**

In response to the Federal Energy Regulatory Commission’s (Commission) May 12, 2009, Notice of Application Accepted for Filing, Soliciting Motions to Intervene and Protests, Ready for Environmental Analysis, and Soliciting Comments, Recommendations, and Terms and Conditions, and as provided in Rule 214(a)(2) of the Commission’s procedural regulations, 18 C.F.R. § 385.214(a)(2), the Department of the Interior (Department) hereby files its Notice of Intervention in the Kilarc-Cow Creek Hydroelectric Project (Project) license surrender and decommissioning proceeding. The Department intervenes in support of the application to surrender and decommission the Project, and for the purpose of becoming a party. Pursuant to 18 C.F.R. § 385.214(a)(2), the Department of the Interior’s Notice of Intervention, filed within the timing requirements set forth in the Commission’s May 12, 2009, Notice, entitles the Department and its component bureaus to party status in this proceeding.

Pacific Gas & Electric Company (PG&E) on March 12, 2009, filed a License Surrender Application with the Commission, seeking to surrender its license to operate the Project and to decommission Project facilities. The existing five (5) megawatt Project consists of two

developments, Kilarc and Cow Creek developments. PG&E proposes to decommission and remove diversion dams; stop water diversions and to allow for free passage of fish and sediment; to leave in place some diversion dam abutments and foundations, and powerhouse structures; to remove electric generators, turbines and other equipment; to grade and fill forebays; and to leave in place, breach or fill canal segments. In 2005, PG&E entered into the Kilarc-Cow Creek Project Agreement (Agreement) with the U.S. Fish and Wildlife Service, the National Park Service, the California Department of Fish and Game, the California State Water Resources Control Board, NOAA Fisheries, Friends of the River and Trout Unlimited, agreeing not to file an application for new license and to support the decommissioning of the Project. The Project may affect species listed under the Federal Endangered Species Act, including the Central Valley Steelhead distinct population segment, the Central Valley spring-run Chinook salmon distinct population segment, the California red-legged frog, valley elderberry longhorn beetle, and northern spotted owl.

The Department has statutory responsibilities and represents national public interests that could be affected by the surrender of the license and decommissioning of this Project. These responsibilities include unique statutory authorities that demonstrate Congressional intent that the Department act in the public interest to protect and promote the public lands, fish, wildlife, tribal and recreational interests, and to represent those interests that could be directly affected by the decommissioning of the Project and removal of some Project facilities. No other party or intervenor has such authority to represent these particular national public interests.
